 For proof of student status, provide **one** of the following:
 - Enrollment summary (from OneStop)
 - Letter on school stationery from the registrar or dean (with school seal) stating that you are enrolled during the 2007–08 academic year at an accredited institution and working toward a diploma or degree
 - Photocopy of transcripts dated within six months of application
 - Copy of email of acceptance to a Learning Abroad Center program
 - Current, validated college or university ID cards if the current academic year is shown on the card (U Cards and photocopies are **not** acceptable)
3. Copy of driver's license, passport, or birth certificate (in addition to the required photo for the identification card)
4. Payment of \$22.00
